

## BEXHILL-ON-SEA TOWN COUNCIL

Minutes of the meeting of **BEXHILL-ON-SEA TOWN COUNCIL Climate, Nature and Environment Committee** held at the **Town Hall Committee Room** on **Wednesday 26<sup>th</sup> January 2022 at 6.30pm**

**00455.** In the absence of the Vice Chairman or Chairman it was **RESOLVED** to appoint Cllr Plim to the position of Chairman

**00456. APOLOGIES FOR ABSENCE**  
It was **RESOLVED** to receive and accept apologies for absence with reasons from Cllr Izzard. Cllr Wray was absent.

**00457. DECLARATIONS OF PECUNIARY AND NON-PECUNIARY INTERESTS**  
There were none.

**00458. CHAIRMAN'S ANNOUNCEMENTS**  
There were none

**00459. PUBLIC PARTICIPATION**  
Cllr Blagrove addressed the meeting and asked four specific questions:

1. What is the aim of debating COVID 19 and is there an explanation of what the end goal and benefit to the Bexhill residents would be?
2. Why is Cllr Izzard making recommendations to this council about COVID?
3. Is Cllr Izzard the self-appointed health minister for Bexhill?
4. Why is Cllr Izzard using the town council to make political points?

**00460. TO ADJOURN THE MEETING TO RECEIVE PRESENTATION FROM THE BEXHILL MUSEUM ON THEIR IDEAS ABOUT THE ENVIRONMENT.**  
A representative of the Bexhill museum explained how the organisation is tackling the threat of flood risk and the reducing its carbon footprint through heat pumps, solar panels and insulation to create more efficient energy use.

**00461. MINUTES**  
It was **RESOLVED** to sign and approve the minutes from the meeting of the 10<sup>th</sup> November 2021 and 8<sup>th</sup> December 2021.

**00462. TO RECEIVE NOTES FROM WORKING GROUPS**

- b) Beach and Sea Working Group

**00463. UPDATE ON CLIMATE CHANGE ACTIONS FROM LAST MEETING**

- a) To receive any update on changes made by councillors or staff on the council decision that they reduce their own carbon emissions where possible, for instance using public transport or walking/cycling or car sharing to local meetings.  
Cllr Thomas reported that he has been car sharing, made positive changes to his property and has stopped using aerosols to shave.
- b) To consider how the committee develops a carbon monitoring system to assess, monitor and reduce its own carbon footprint.  
It was **RESOLVED** to defer this item until the council rents a property.
- c) To consider how the council can ensure plans are developed to make any premises it takes on carbon neutral with a target of 2025.  
It was **RESOLVED** to defer this item until the council rents a property.
- d) To note that the Council has applied for the National Lottery Together for our Planet funding – noted.
- e) To note no councillors or staff members have agreed to attend the course dates for Zero Carbon Britain: Carbon Literacy for Local Authorities course.  
Cllr Taylor-Gee and Cllr Thomas requested to attend the training in May.

**00464. ENVIRONMENTAL MATTERS**

- a) To receive update from Rother District Council on graffiti issues.  
It was noted that Biffa remove graffiti from RDC owned property.
- b) To receive update from Rother District Council on chemical weed spraying.  
It was noted that the town council is not able to directly inform the policy of RDC and the cost and effectiveness of more environmentally friendly methods is being reviewed regularly.
- c) To receive update from Rother District Council on Electric Vehicle Charging points.  
It was noted that the RDC cabinet is considering contracting out the supply and maintenance of EVC points at its meeting in February.

- d) To note flower display expert contact details being passed to the clerk following last meeting – it was noted Cllr Carroll will contact the resident and refer to the clerk.
- e) To discuss Cllr Thomas' recommendations from the Chief Medical Officers Report 2021.  
Cllr Thomas circulated a report at the meeting which was noted.
- f) To note 'Hello Bexhill' projects being progressed and a report will follow at the next meeting.  
Cllr Carroll will ask if the bench could be used in the Polegrove.  
A bench along the front will be requested from RDC.
- g) To debate COVID 19 (Cllr Izzard)  
This item was deferred until Cllr Izzard is present.
